All other students' fees are protected by maximum year-on-year fee increases of 5% above inflation (inflation being defined by the consumer price index in the preceding January). Fees for subsequent years of any programme will be confirmed prior to that academic year, and are payable before commencing that year of the programme.

* An ELQ student is one studying for an equivalent or lower qualification to one they already hold. For example, one who already holds a Masters qualification and is studying for another MA at Central. Central receives no government funding for such students. Certain students, such as those in receipt of Disabled Students' Allowance (DSA), are exempt from the ELQ ruling.

± Students holding a PGCE as their highest qualification are exempt from paying ELQ fees for this programme; fees would be set at the 'Home/EU' rate for such students. Students holding a Masters (or higher) would be liable for the ELQ fees.
